NRC Scholarship Program Now Open

The NRC scholarship program is now open.

ELIGIBILITY

To be eligible for consideration, an applicant must:

- * be a son, daughter, grandson, or granddaughter of a current employee of an NRC member company; and
- * be enrolled at the time of application as a full-time college student at an accredited two-year college offering an associate's degree or an accredited four-year college or university offering a bachelor's degree, or as a recently graduated high school senior that is enrolled to start college this fall.

AMOUNT OF AWARDS

Three scholarships will be awarded as follows: the first place applicant will receive \$8,000, the second place applicant will receive \$4,000, and the third place applicant will receive \$2,000. Scholarship funds, awarded annually, will be sent directly to the student at the beginning of the next term of study. Students must be in attendance for a full year following receipt of the award.

RFP: Wisconsin & Southern Railroad, LLC Markesan Subdivision Tie, Crossing and Turnout
Project in Fairwater, WI and Markesan, WI

Location: Fairwater, WI and Markesan, WI

Description: The contractor shall supply all supervision, labor, equipment, and material (except that material specifically designated to be supplied by the Wisconsin & Southern Railroad) to perform tie replacement, road crossing replacement, turnout replacement and continuously welded rail (CWR) installation on the Markesan Subdivision of the Wisconsin & Southern Railroad (henceforth RAILROAD) between Mile Post 165.34 in Fairwater to Mile Post 172.67 in Markesan, Wisconsin in accordance to the Project Documents. Work includes, but is not limited to, the following:

- Replace 4,000 CONTRACTOR-supplied crossties that have been previously marked by the RAILROAD for replacement;
- Replace six (6) at-grade railroad crossings;
- Replace six (6) AREMA turnout packages;
- Install continuously welded rail for approximately 400 linear feet;
- Establish necessary erosion control measures and

RTD Recommends Balfour Beatty Infrastructure Proposal

Staff of Denver's Regional Transportation District (RTD) recommended that the RTD Board of Directors move forward with a proposal from Balfour Beatty Infrastructure Inc. to design and build the Southeast Rail Extension.

The Balfour Beatty Infrastructure team includes Parsons Brinckerhoff (design); Capitol Management (DBE/SBE/WIN); Transit Safety & Security Solutions (system safety); Systems Consulting, LLC (quality assurance) and Communication Infrastructure Group (public information).

The Southeast Rail Extension will build an additional 2.3 miles of light-rail line that will run along the west side of I-25 from the Lincoln Station and then cross over the Interstate and run along the east side of the highway to the south side of RidgeGate Parkway in Douglas County.

RailPros has been awarded a contract by the Alameda Corridor-East Construction Authority to provide preliminary engineering and final design services for a grade crossing improvement project in Ponoma, Calif. The project is designed to enhance vehicular and pedestrian safety at four existing crossings in Pomona along Union Pacific Railroad's Alhambra and Los Angeles Subdivisions. The scope of services includes performing site studies and developing concept plans for proposed improvements.

Massachusetts, New York DOTs Provide Funding for Freight-Rail Projects

The Massachusetts Department of Transportation (MassDOT) has awarded five grants totaling more than \$2 million for freight-rail projects as part of the 2015 Industrial Rail Access Program (IRAP).

The grants will be matched by more than \$1.7 million in private-sector funds for a total \$3.7 million investment in freight-rail improvements.

The New York State Department of Transportation (NYSDOT) is soliciting applications for \$17 million in rail and port facility improvement grants through the state's

Passenger and Freight Rail Assistance Program.

The \$17 million will help fund projects aimed at track rehabilitation, railroad bridge repairs, improved emissions, expanded capacity and economic development opportunities.

Applications are due Aug. 27. Railroad operators, industrial development agencies, state and local government agencies, and other authorities are eligible to apply.

CP 2-3 involves 65 miles of infrastructure improvements, including over 10 million yards of new high-speed rail embankment, 23 high-speed rail structures and 32 new grade separations.
